- 1. There is no charge for the hire of the bar.  
For any venue other than Grittenham Barn, there is a one-off fee of £250 that covers transportation and labour costs. There is a flat fee of £21 for the events licence for any venue other than Grittenham Barn.*
- 2. You agree to pay a deposit of £250\* as confirmation of your booking and is fully-refundable after the event has taken place, excluding glass breakages\*\* and recycling of all bar waste\*\*\*.  
Cancellation fees apply\*\*\*\*.  
N.B. For any venue other than Grittenham Barn, there is an additional charge of £271, which must be paid alongside the deposit.*
- 3. Drinks from the day must be cleared before the bar service commences. All alcohol beverages and soft drinks must be purchased from the bar.*

4. *We require an agreement of a minimum spend of £1000. Your signature at the end of this form shows agreement.*

5. *We have a strict policy for serving anyone under the age of 18. ID may be required.*

6. *We have the right to refuse the sale of alcoholic beverages to any person for any reason.*
